patent lawsuit against Microsoft. Following the hard-fought case against an excellent defense team, the jury awarded our client

\$200 million. As a testament to the good work of our trial team, the verdict was later entered as a judgment for more than \$290 million and already has survived one round of appeals. *The National Law Journal* ranked this win as the nation's 10th largest jury verdict for the year.

We also helped another technology company win a \$138 million patent infringement verdict against one of the world's biggest software providers, Germany's SAPAG. This case was won with technical expertise and hard work from our deep bench of trial lawyers. Like the win against Microsoft, our team tried this case in the U.S. District Court for the Eastern District of Texas. During the past 20 years, McKool Smith has developed a

thriving practice in the Eastern District, one of the country's top jurisdictions for complex commercial cases and patent litigation.

We're also very proud of our win for the City of San Antonio and more than 170 other Texas cities in the first state court trial over unpaid hotel occupancy taxes. The \$20 million verdict in that case has impacted similar cases across the country, and earned extensive media coverage in the U.S. and overseas.

Finally, our team took on some of the top defense lawyers on the east coast when we went up against computer giant Apple Inc. in a

patent infringement lawsuit. When the trial concluded, jurors found for our client and awarded \$19 million. In addition to confirming

the validity of our client's patent, the jury also delivered a willful infringement finding against Apple.

While everyone at our firm is proud of these trial results, we aren't sitting still. Now with more than 125 lawyers, McKool Smith has opened new offices in New York and Houston during the past two years.
